



SABA 2024 ANNUAL CONFERENCE



Each year, SABA North America holds its Annual Conference to bring together attorneys from across its 30 chapters in the United States and Canada. Last year's 19th Annual Conference – the Next Revolution - was held in majestic Boston, and it was our most well-attended Conference ever, with over 800 participants. Over three days, we provide participants the chance to re-connect with old friends and make new ones, learn about cutting edge issues and celebrate each other's successes and accomplishments. In Boston, we heard from leading luminaries, like U.S. Attorney for the Southern District of Texas, Alamdar Hamdani, General Counsel of the U.S. Federal Trade Commission, Anisha Dasgupta, General Counsel of leading global alternative investment firm Wafra, Sumana Setty, and Chief Appellate Counsel and Managing Attorney for the Sierra Club, Sanjay Narayan, to name just a few. We heard firsthand about the lessons learned from the apprehension and prosecution of the Boston Marathon bombers from former Assistant U.S. Attorneys Aloke Chakravarty and George P. Varghese (ably moderated by former U.S. Attorney for the Southern District of New York, Preet Bharara). This year's conference also included a summit for corporate counsel, as well as SABA's first national pitch program pairing law firms and corporate clients considering new representation. We topped it off with a spectacular Gala featuring Madame Justice Renu Mandhane of the Ontario Superior Court of Justice (Brampton) and musical guests, Fateh and Simar!

Our planning for our 2024 Conference is well underway. SABA's 20th Annual Conference will be held at the premier Toronto Hilton from July 11-14, 2024 (**#passporttothefuture**). This will be a unique opportunity for SABA to showcase its largest Chapter, with over 1000 local members, and highlight talent, leadership, and SABA lawyers from both the U.S. and Canada. We anticipate our Toronto Conference to be our largest conference ever, and we are ecstatic to partner with new and established sponsors for another spectacular year.

SABA LOBBY WEEK

Since 2017, SABA has conducted a Lobby Day or now more accurately Lobby Week that brings SABA attorneys to Washington, D.C., whether virtually or in-person¹, to meet with Congressional members and discuss pressing issues to SABA Members and our community. Lobby Week allows SABA to amplify its voice on behalf of the community, and to develop relationships with political leaders and staff.

During Lobby Week, SABA Members will participate in virtual advocacy meetings in Spring, 2024². Prior to Lobby Week, registered participants will attend training sessions to gain a deeper understanding of the issues that affect the South Asian community and how to effectively communicate them to Congressional offices.
