

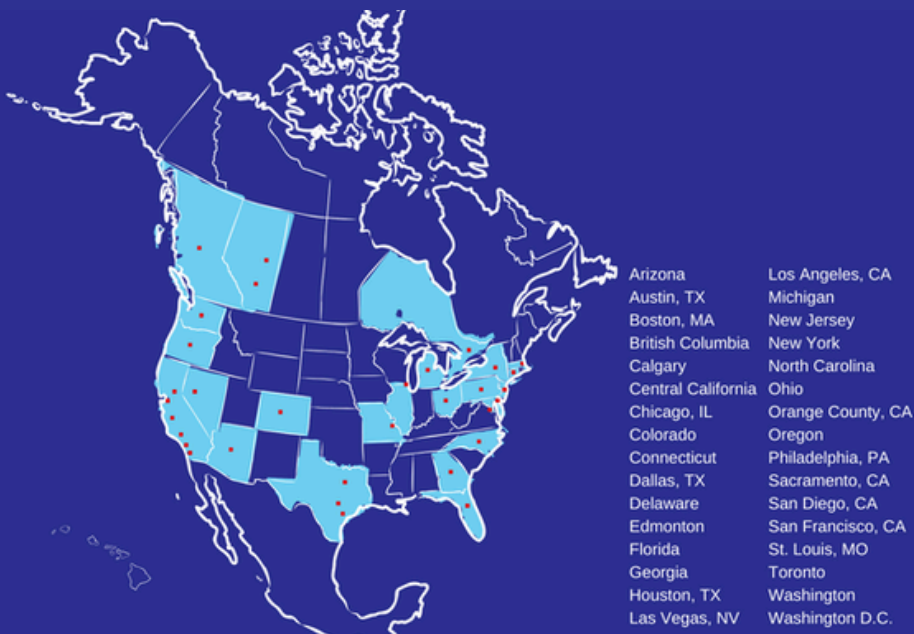

Vendor / Exhibitor Sponsorship Options for Conference:

Exhibitor sponsorships / vendor sponsorships begin at \$5,000, and include a table (if you would like) at the annual conference, 1 registration, and recognition on website, social media, and digital content. A La Carte Options:

Mobile App Sponsor: \$12,500: Limited to 1 Sponsor (First Come, First Serve) (in consultation with our app's rules and regulations)

All Sponsor Conference registrations will include admission to the Gala on Saturday evening, For Title sponsors, we will provide reserved seating near the front of the Gala room for up to 10 Sponsor Attendees, provided that the Sponsor confirms how many of its Attendees will be using that seating by no later than two weeks before the start of the Conference. To the extent a Sponsor is only able to use a portion of its reserved seating, SABA reserves the right to seat other guests at the Sponsor's reserved table.

Premiere Events sponsorship / co-sponsorship are on a first-come, first-serve basis, provided that the sponsorship is confirmed by April 30, 2026. For any sponsors confirmed after this date, it is expressly understood that sponsorship of premiere events may not be available.

Y⁴ Diamond Sponsors are given first-come, first serve opportunities to speak at SLI events throughout the year (of which there are 6 sessions with multiple speaking opportunities). To the extent that any slots are unfulfilled by the Diamond sponsor, then the Ruby sponsors will be able to speak at SLI events on a first-come first serve basis. All small / solo firm sponsors will be given 1 opportunity to speak (e.g., 1 session). All session conversations are confidential.

SABA CORPORATE COUNSEL RETREAT



In January 2026, SABA will host its annual Corporate Counsel Retreat (“CCR”). The Retreat brings together a small group of mid to senior-level in-house counsel for a weekend focused on in-person professional development, networking, mentoring, and team building. Educational sessions are presented by “Retreat Faculty” selected from influential industry leaders and prominent sponsor representatives who showcase their experience and thought leadership. The Retreat also gives sponsoring law firms the chance to interact with Retreat attendees during curated small-group dinners. This year’s Retreat also features opportunities to participate in a recreational activity, such as, golf/pickleball/tennis and pairs up sponsors and Retreat attendees.

Please note that sponsorships for the Retreat are carefully limited, and Retreat attendees are carefully selected through an application process to ensure an appropriate mix of seniority and geographic and industry diversity. KEY STAKEHOLDER DINNER AT SABA LOBBY WEEK

Since 2017, SABA North America conducts an annual Lobby Week, and brings SABA North America attorneys to Washington, D.C. to meet with Congressional and Senate members and discuss pressing issues to the greater SABA community. Lobby Week allows SABA to amplify its voice on behalf of the community we serve, develop and maintain relationships with political leaders and staff, and meet with key stakeholders in intimate settings.

SABA North America is a nonpartisan organization and our meetings in D.C. are with Congressional and Senate members from both sides of the aisle. We believe that real, tangible results are achievable and oftentimes SABA North America acts as a go between amongst Congressional and Senate members who otherwise may not realize the efforts each is working on.

Some highlights and takeaways from past years have included the following:

- Key note speech by Congresswoman Judy Chu at the SABA North America Lobby Week's Welcome Reception;
- Working on bipartisan bills with key stakeholders relating to issues of immigration;
- Advancing our judicial nominations by meeting with key Senate Judiciary Committee staff;
- Becoming a key voice for proposed rulemaking surrounding H1-B visas;
- Proposing legislation that would assist our members in areas of immigration, reproductive justice, and voting rights

For law firms that have public policy practice group, political law practice group, election campaign practice group, and/or for firms that specialize in the core advocacy areas of SABA North America (immigration, reproductive justice, voting rights), being a part of our Key Stakeholder Dinner at Lobby Week is a unique opportunity to have your firm present at a unique networking dinner in D.C.
